Credit Terms Agreement

In consideration of Midwest Petroleum Equipment, LLC and its subsidiaries extending credit to applicant, applicant agrees to pay for all services provided and products delivered to or requested by applicant from Midwest Petroleum Equipment, LLC. Terms of sale are net due not later than the stated terms listed below. Applicant acknowledges that a service charge of 1.33% per month of all sums due Midwest Petroleum Equipment, LLC which have not been paid within terms will be charged to applicant by Midwest Petroleum Equipment, LLC and agrees to promptly pay said service charge. An additional service charge, computed on the same basis, will be due and payable every thirty (30) days thereafter until said sums are paid in full. Waiver of any one or more service charges shall not be deemed to be a waiver of future service charges.

In the event that Midwest Petroleum Equipment, LLC commences litigation or employs attorneys or collection agents in order to secure payment of any sums due from applicant, the applicant agrees to pay such collection or attorney's fees, to the extent permitted by applicable law, and any court costs, in addition to all other sums due.
